**FRESH VENT™ Air Conditioning Freshener**

**DESCRIPTION**

Fresh Vent™ quickly and easily clears foul odors from automobile air/heat duct systems and interiors.. More than just a cover-up, Fresh Vent™ freshens foul smelling systems at their source. Cleans and neutralizes a variety of foul odors including odors from mold, mildew and algae. Leaves behind a "factory fresh" interior.

**USES**

- Prevent and correct foul or musty smelling air and heat duct systems.

**DIRECTIONS**

NOTE: Fresh Vent™ may affect certain plastics and paints. If unsure, test product in an inconspicuous area before using. If the vehicle is equipped with a cabin air filter (located in the air intake system prior to the blower motor), it must be removed prior to treatment with Fresh Vent™ and reinstalled or replaced after system treatment. Turn the blower on medium, set the temperature to full cold, place the air intake control in fresh air position, lower vehicle windows, and spray the can horizontally across the air intake in the vehicle cowl area. After the can is expended, let the blower run for 10 to 15 minutes. Avoid changing blower speed during or immediately after service. Blower switch could produce sparks which could potentially ignite Fresh Vent™ product. After 10-15 minutes switch the temperature control to full heat and run the car for an additional 10 to 15 minutes with the windows down.

**STORAGE**

Do not store in temperatures above 120°F (50°C). Do not puncture, incinerate or burn. Do not place near sources of heat. Keep from freezing.
