Directions:

1. If the vehicle is equipped with a cabin air filter (located in the air intake system prior to the blower motor), it must be removed prior to treatment with FRESH VENT™ and reinstalled or replaced after system treatment.
2. Turn the blower on medium, set the temperature to full cold, place the air intake control in fresh air position, lower the vehicle windows, and spray the can horizontally across the air intake in the vehicle cowl area. After the can is expended, let the blower run for 10 to 15 minutes. Avoid changing blower speed during or immediately after service. Blower switch could produce sparks which could potentially ignite FRESH VENT™ product.
3. After 10-15 minutes switch the temperature control to full heat and run the car for an additional 10 to 15 minutes with the windows down.

NOTE: FRESH VENT™ may affect certain plastics and paints. If unsure, test product in an inconspicuous area before using.

Storage:
