Directions:

If the vehicle is equipped with a cabin air filter (located in the air intake system prior to the blower motor), it must be removed prior to treatment with FRESH VENT+™ and reinstalled or replaced after system treatment. With windows closed, set the blower to medium, set the temperature to full cold, place the can horizontally across the air intake on the outside of the vehicle in the cowl area at the base of the windshield. Spray entire contents of can into the cowl air intake and let the blower run for 10 to 15 minutes. Avoid changing blower speed during treatment process as sparks could potentially ignite FRESH VENT+™ product. After 10-15 minutes, switch the temperature control to full heat and run vehicle for an additional 10-15 minutes with the windows down. Treatment is now complete.

COMPOSITIONAL INFORMATION
